





3-Area of intervention

III- Analysis of the context and the problem

In terms of economic justice, women face significant barriers, including limited access to resources such as land, capital, and employment opportunities.

Patriarchal cultural norms, combined with a lack of education and persistent gender discrimination, lead to the underrepresentation of women in the formal economy, making them vulnerable to poverty and exposing them to forms of exploitation. Furthermore, harmful practices such as child marriage and female genital mutilation are realities many women endure, often due to deeply entrenched cultural norms that hinder their education and empowerment.

These practices exacerbate inequality and deprive women of their fundamental rights, keeping them dependent and vulnerable. Women's human rights are often restricted, and their voices are frequently ignored in contexts where violence and conflict are widespread. Sexual violence in armed conflict is of particular concern, reinforcing the need to include women in peace and security processes, as their participation is crucial to ensuring lasting solutions. The lack of commitment to women's rights in these contexts reinforces cycles of violence and exclusion that perpetuate gender inequalities. In short, an analysis



of the women's rights context in sub-Saharan Africa highlights a complex interconnection between these different domains. To advance equal rights, it is essential to adopt a holistic approach that not only addresses economic injustices and health challenges, but also addresses issues of climate justice and harmful practices. Mobilizing governments, civil society organizations, and the international community is crucial to developing integrated strategies that support women's empowerment and ensure their active participation in all aspects of social, economic, and political life, thus contributing to a more egalitarian and peaceful future.

V- How we drive our changes : our paths

RFLD's theory of change for ISE in sub-Saharan Africa emphasizes the interdependence of individual, organizational, community, and environmental factors to foster sustainable change. We believe that achieving ISE requires a holistic approach that simultaneously addresses structural and individual barriers.

Key elements of our theory of change :



1-Empowerment of individuals

Empowering individuals is central to the Network of Women Leaders for Development's (RFLD) theory of change. It is essential to provide women and marginalized groups with the tools they need to become aware of their rights and strengthen their capacity for action. This involves an education and awareness-raising process that enables individuals to understand not only their fundamental rights but also the mechanisms through which they can claim these rights. Targeted training programs aim to develop leadership, advocacy, and digital literacy skills, essential in an increasingly digitalized world.

Leadership training includes practical workshops where participants can develop communication, conflict management, and decision-making skills. These skills are crucial for empowering women to assert themselves in traditionally male-dominated spaces, giving them the confidence to express their opinions and influence decisions that affect them. Additionally, their ability to advocate for change within their communities is strengthened through advocacy training, where they learn to formulate clear demands and present them effectively to decision-makers.

2- Transformation of organizations

Once these barriers are identified, the RFLD works with organizations to develop strategies that foster an inclusive work environment. This may include training leaders and employees on gender issues to raise awareness and educate on the importance of equality in the workplace.

By integrating this perspective into its programs, RFLD ensures that interventions are not limited to a one-size-fits-all approach, but rather take into account the diverse realities experienced by women.

RFLD also strives to train its partners and collaborators on the importance of intersectionality. 



This additional burden limits their time and opportunities for economic advancement and reinforces existing gender inequalities.
