About This Document

This Investment Prospectus outlines RFLD's strategic plan for 2026–2030 and the transformative impact of a \$15 million investment in permanent feminist infrastructure across Africa. We present a unique opportunity to scale proven models, multiply impact through sub-granting, and create sustainable systems change affecting 100+ million women across 55 countries.

Executive Summary

The Investment Ask

\$15,000,000 over five years (2026–2030)

To build permanent feminist infrastructure that transforms how gender justice is funded, coordinated, and won across 55 African countries.

Why This Matters Now

African feminist movements are at an inflection point. For decades, they have been fragmented, under-resourced, and dependent on northern donors. RFLD has spent 12 years building the connective tissue—and we're ready to scale.

With Observer Status at the African Commission on Human and Peoples' Rights (ACHPR), a validated sub-granting model through the West Africa Francophone Feminist Fund (WAFFF), and a Data Center cited by 12 African governments, RFLD is uniquely positioned to become the **operating system for African feminist movements**.

The Opportunity

The Problem: A Funding Crisis for African Feminism

African women's organizations receive **less than 1% of global gender equality funding**—and almost none of it goes directly to grassroots groups. The result is a continent where feminist movements are fragmented, under-resourced, and unable to coordinate at the scale needed to win systemic change.

The Solution: Infrastructure, Not Just Programs

Most philanthropy funds *activities*. We're building *infrastructure*—the permanent systems that allow African feminists to coordinate, fund each other, access real-time data, and engage decision-makers at continental scale.

What Infrastructure Looks Like

- **Sub-Granting:** WAFFF and 3 new regional feminist funds providing flexible, rapid funding directly to grassroots organizations
- **Data Systems:** Dònuèsè Data Center providing real-time legislative tracking, threat monitoring, and policy research for 55 countries
- **Coordination:** Regional hubs connecting 450+ organizations for cross-border advocacy and mutual support
- **Policy Access:** Direct engagement with African Union, ACHPR, and national governments through Observer Status

The Market Gap

No other organization operates at this intersection of **continental reach, feminist values, and infrastructure development**. While some groups focus on advocacy and others on service delivery, RFLD is the only Pan-African feminist network providing the connective tissue—funding, data, coordination—that transforms fragmented efforts into a coordinated movement.

2024–2025 created unprecedented momentum:

- ACHPR Observer Status granted (2024)
- WAFFF validated: 50 organizations funded with 1:1.4 ROI on capacity building
- Data Center cited by 12 governments in policy decisions
- 156,000-strong leadership pipeline demonstrated

To build permanent feminist infrastructure that enables African women and girls to claim their rights, lead their communities, and transform the systems that shape their lives.

Our Vision

A continent where feminist movements have the resources, coordination, and political power to win systemic change—and where African women are not beneficiaries but architects of their own futures.

What Makes Us Different

1. Continental Scale with Local Roots

We operate in 55 countries through 450 member organizations—from Senegal to Somalia, from Egypt to South Africa. Our members are locally-led feminist groups who know their communities and drive change from the ground up.

2. Infrastructure, Not Just Programs

We don't just run projects. We build the systems—funding mechanisms, data platforms, coordination networks—that enable the entire ecosystem to function and scale.

3. Feminist Funding Feminist Movements

Through WAFFF and emerging regional funds, we are African feminists funding African feminists—with flexible, rapid grants and capacity building that respects local expertise.

4. Data-Driven Advocacy

Our Dònuèsè Data Center provides real-time tracking of legislation, violence against women, and civic space—cited by 12 governments and used by hundreds of advocates.

5. Direct Access to Decision-Makers

As an ACHPR Observer, we have a seat at the table where continental human rights policy is made—and we bring the voices of 450 organizations with us.

Pillar 2: Data & Research Infrastructure — \$4,500,000 (30%)

Expanding the Dònuèsè Data Center

- **Real-Time Legislative Tracking:** \$1.5M — Monitor gender-related legislation across 55 countries with AI-powered alerts
- **Policy Research & Briefs:** \$1M — Quarterly policy briefs for all 55 countries; shadow reports for ACHPR/CEDAW
- **Digital Safety Compendium:** \$750K — Expand from 150 to 500+ resources; add 20 languages
- **Data Partnerships:** \$500K — Collaborate with 10 African universities for feminist research
- **Annual State of African Feminism Report:** \$500K — Flagship publication cited by governments, donors, and UN agencies
- **Technology & Systems:** \$250K — Infrastructure, security, and platform maintenance

Impact: 50 governments citing RFLD data by 2030; 2,000+ advocates using Data Center tools.

Pillar 3: Network Coordination — \$3,000,000 (20%)

Strengthening Pan-African Feminist Coordination

- **Regional Coordinators:** \$1.2M — 4 full-time coordinators (East, Central, Southern, North Africa)
- **Pan-African Feminist Conventions:** \$1M — Biennial convenings (2026, 2028, 2030) with 500+ participants

- **Communications & Narrative:** \$300K — Multimedia storytelling; website; social media
- **Regional Convenings:** \$100K — 5 regional meetings annually

Pillar 4: Sustainability Mechanisms — \$1,000,000 (6.7%)

- **Endowment Seed Capital:** \$400K
- **Earned Revenue Development:** \$300K — Consulting services for governments/multilaterals
- **African Feminist Donor Circle:** \$200K — Cultivate African philanthropists and diaspora

Pillar 5: Organizational Excellence — \$500,000 (3.3%)

- **Leadership Development:** \$200K
- **Systems Strengthening:** \$200K — Finance, HR, IT, compliance
- **External Audits & Legal:** \$100K

Our Strategic Framework: 7 Pillars

RFLD's work is guided by **7 Strategic Pillars** that span the full spectrum of feminist organizing—from rights and representation to ending harmful practices. These pillars inform our funding, advocacy, and capacity-building across 55 countries.

01 Rights & Representation

Advocate for Maputo Protocol ratification, SRHR access, bodily autonomy, and women's leadership in governance.

02 Civic Space & Democracy

Defend civil liberties, monitor threats to women activists, and promote inclusive electoral processes.

03 Economic Power & Climate Justice

Drive economic empowerment, secure land rights for women, and advance gender-responsive climate policies.

04 Participatory Governance & Media

Strengthen civil society capacity for budget monitoring, policy engagement, and gender-sensitive journalism.

05 Human Rights Protection

Monitor and document violations, provide emergency legal aid and shelter for Women Human Rights Defenders (WHRDs).

06 Peace & Security

Advance the Women, Peace & Security agenda; support women mediators; address gender-based violence in conflict.

7 Elimination of Harmful Practices

End FGM, child marriage, and widowhood rites through community campaigns and survivor support services.

Theory of Change

How \$15M Becomes Systems Change

RFLD's theory of change is built on a simple premise: **infrastructure multiplies impact**. By investing in the connective tissue—funding mechanisms, data systems, coordination—you enable an entire ecosystem to function at higher capacity.

Stage 1: Infrastructure Investment (\$15M)

Your investment builds permanent systems:

- 4 regional feminist funds providing flexible, rapid grants
- Data Center offering real-time legislative tracking and threat monitoring
- Coordination hubs connecting 450+ organizations across 55 countries
- Policy access through ACHPR Observer Status

Stage 2: Ecosystem Activation (\$45M in Sub-Grants)

Infrastructure enables RFLD to mobilize and deploy additional capital:

- 600+ grassroots organizations receive \$5K–\$30K grants annually
- Organizations strengthen capacity: financial management, fundraising, digital security
- Feminist groups coordinate across borders using shared data and platforms

Stage 3: Movement Power (1.5M Leaders)

Funded, coordinated organizations build leadership at scale:

- 1.5 million women transition from beneficiaries to leaders

Stage 5: Systems Change (100M+ Women)

- Girls inherit land; women access reproductive healthcare; survivors find justice
- Gender norms shift; patriarchal structures weaken; new futures become possible
